ABOUT SAINT LUCIA

Saint Lucia is a sovereign island country in the Eastern Caribbean Sea. Saint Lucia is an island of the Lesser Antilles belonging to the Commonwealth and is located in the West Indies in the Eastern Caribbean Sea. The island is known for its tropical climate, unique natural scenery with breathtaking mountain panoramas and lush rain forests. Applicants and their dependants are not required to live in Saint Lucia to obtain citizenship, meaning you can apply for and receive secondary passports without having to relocate the entire family or renounce your original nationality.

TRAVEL WITH EASE

As a citizen of Saint Lucia, you gain access to visa-free travel to over 140 countries, including all Schengen states, the United Kingdom, most British Commonwealth member countries and Latin America, making a citizenship in Saint Lucia an extremely attractive choice. Furthermore, with your Saint Lucia passport, obtaining most foreign visas for you and your family will be a smooth and easy process.

TAKE ADVANTAGE OF NEW BUSINESS OPPORTUNITIES

Saint Lucia passport holders benefit from an attractive tax regime:

No wealth, gift, inheritance, foreign income, or capital gains tax, as well as no personal income tax. Furthermore, you will have access to generous incentive packages including corporate tax incentives, full exemption from import duties, tax relief benefits and export allowances.

Saint Lucia ranks 93rd in the 'Doing Business Report' by the World Bank, 8th overall in Latin America and 2nd in the Caribbean Region.

SECURE YOUR FAMILY'S FUTURE

Your spouse, children below the age of 25 and dependant parents over the age of 65 can apply to obtain their Saint Lucia passports along with you, and will be able to enjoy life on one of the most developed islands in the Caribbean, with excellent access to healthcare services all over the island.

INVESTMENT OPTIONS

There are two different investment options which serve as a qualifier for your application to the Saint Lucia citizenship-by-investment programme:

OPTION 1

National Economic Fund (NEF) Contribution

- Main applicant: **USD 100,000.**
- Main applicant and spouse: **USD 165,000.**
- Family of up to 4: **USD 190,000.**
- Each additional dependant: **USD 25,000.**

(Contribution is non-refundable).

OPTION 2

Real Estate Investment

- Minimum investment in an approved real estate project: **USD 300,000.**

PROCESS AND TIMELINE

Month 1-2 Sign retainer agreement and pay the first retainer invoice.
Preparation

Prepare required documentation.

Payment of government fees, due diligence, citizenship application and legal fees.

Submit citizenship application.

Month 3 Receive an approval letter from
Citizenship by-Investment Unit.
Citizenship application

Select your preferred investment option:


- The National Economic Fund (NEF) donation fees will be paid directly to the government.
- The Real estate investment will be paid directly to the developer's escrow account.


Month 4 Citizenship Certificate of Naturalisation is issued.
Receive Saint Lucian passport is granted thereafter.
