ST. LUCIA NATIONAL ECONOMIC FUND (NEF)

A contribution into the National Economic Fund (NEF) amounting to a minimum of US\$ 100,000 for a single applicant, or US\$ 150,000 for up to four persons including the Main Applicant. The contribution is in the form of a onetime payment.

ST. LUCIA APPROVED PROJECT (REAL ESTATE)

Applicants are required to make an investment in an approved real estate project with value of at least US \$300,000 plus the payment of the government processing fees and due diligence fees.

ST. LUCIA COVID BOND (NEW OPTION)

Prospective citizens will be able to qualify through the purchase of a new, non-interestbearing bond with a five-year holding period, called the COVID-19 Relief Bond, for US\$250,000 (as opposed to US\$500,000 under the conventional bond option) for a single applicant. This option is valid through December 31st, 2020.
