

MAIN APPLICANT REQUIREMENTS

Applicants are required to demonstrate the capability to support themselves financially in Malaysia without seeking employment or government assistance. The financial requirements upon application are as follows:

For applicants below the age of 50:

- Proof of bankable assets of at least MYR 500,000 (approximately USD 114,000)
- Proof of income of at least MYR 10,000 (approximately USD 2,300) per month

For applicants 50 years old and older:

- Proof of bankable assets of at least MYR 350,000 (approximately USD 80,000)
- Proof of income of at least MYR 10,000 (approximately USD 2,300) per month



Once applicants have received a conditional approval letter, they must meet the following requirements:

For applicants below the age of 50:

- A bank account must be opened with a deposit of at least MYR 300,000 (approximately USD 68,000)
- After a period of one year, up to MYR 150,000 (approximately USD 34,000) may be withdrawn for approved expenses

For applicants 50 years old and older:

- A bank account must be opened with a deposit of at least MYR 150,000 (approximately USD 34,000)
- After a period of one year, up to MYR 50,000 (approximately USD 11,500) may be withdrawn for approved expenses



PROCEDURES

The Ministry of Tourism and Culture is responsible for the processing of all applications. The Immigration Unit will issue a conditional approval letter to each approved applicant. It is important to note that the visa does not allow the holder to work in Malaysia, and it does not lead to permanent residence.
